Improperly stored rags can create conditions that lead to oxidation. Oxidation, under certain conditions, can lead to spontaneous combustion. This product contains antioxidants to retard oxidation.
- Reactivity : Upon combustion: CO and CO<sub>2</sub> are formed.

### 5.3. Advice for firefighters

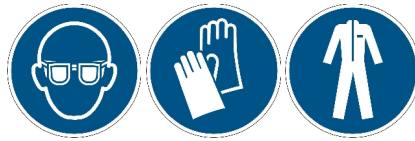

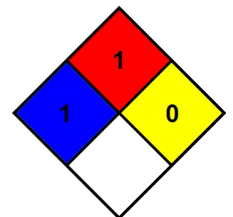
