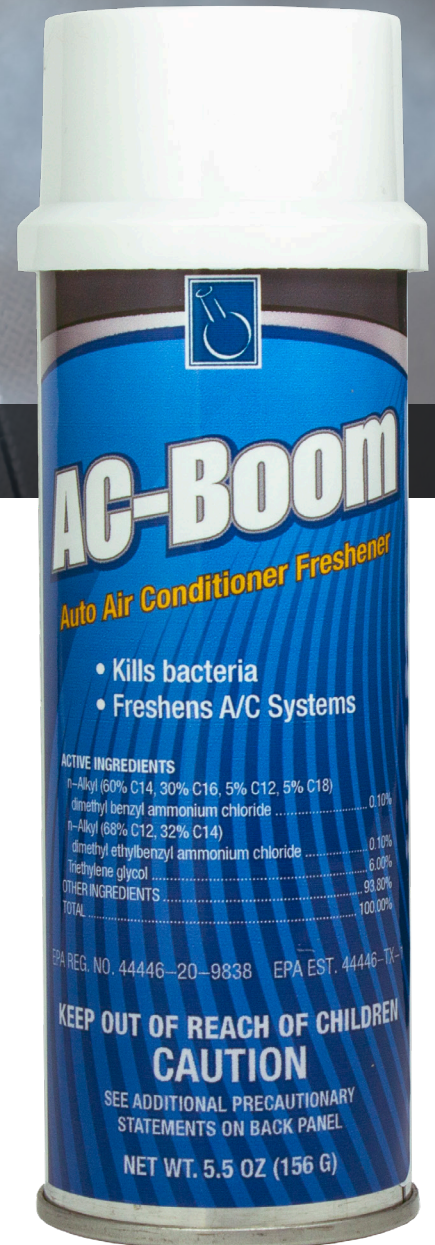

### DIRECTIONS:

Make sure the spray tip is pointed directly at the intake vent before spraying. The recirculating system will pick up the product and the entire system will be deodorized in seconds. Shut off engine and air conditioner after applying the product. After applying product into the air conditioning system, get out of the car immediately. Do not return for 4–10 minutes so air in the compartment can be properly ventilated. If odors persist, repeat treatment as necessary.

**FIRST AID**
